AIMS AND OBJECT: The Aims and Objects of the Society are

 To Organise Residential Educational Institution or Educational Institutions with Hostel Facility in general and more particularly to bring out all round development of children born in communities or areas privileged or underprivileged like scheduled castes and scheduled tribes and to inculcate in them respect for national cultural heritage.

- To uphold national solidarity by inculcating feeling for the best customs and traditions nourished in Bharat Since Immemorable times including Yogic Culture and Samskruthi Bhasha
- To conduct training camps and cultural tours of the county for various age groups of our youth for inculcating the feeling and the concept of motherland to raise the nation again to the pinacle of the glory.
- 4. To acquire the necessary equipment and where with all to implement the above aims and Objects and to do all other things essential for the purpose, provided that the Aims and Objects shall not be amended without prior intimation to and permission of the concerned Commissioner of Income Tax at the relevant time.

MEMBERSHIP

1. Those who subscribed to the memorandum of Association as members.

2. Any person considered to be a desirable person and who agree with the aims and objects of the society and to abide by all rules and regulations of the Society can be 21 Vision Stales light Vision admitted by the Executive as a member.

CEASURE OF MEMBERSHIP ETC.,

1. Any member can voluntarily resign from the membership of the society by writing to that effect to the President.

2. Any member can be removed if it is resolved to do so by executive unanimously on finding that he is acting against the interests and aims and objects of the society.

GENERAL BODY:

The General Body of the Society shall consist of those, who have subscribed their signatures to the Memorandum and those that may b admitted as members at any relevant time. It shall be the supreme authority as regards the affairs of the Society.

MANAGEMENT

- a. The Management of the Society shall vest in the Executive Committee of Jateeya Vidva Seva Samithi, And all institutions that may be started to achieve the aims and objects of the society.
- b. The persons in the Management shall serve purely on honorary basis without any remuneration of any sort.

CONSTITUTION OF EXECUTIVE COMMITTEE

- 1. The Executive Committee shall consist of not less than seven persons to be elected by the General Body. The Executive Committee shall have power to increase the number to a maximum of ELEVEN as and when found necessary by it and to co-opt such members for the term during which co-option is made.
- 2. The First Executive Committee shall be the members who have subscribed their names to the formation of the Society. The quorum for the Executive shall be 3.

GENERAL BODY MEETING

- 1. The General Body of Jateeya Vidya Seva Samithi shall be summoned to meet at least once in a year and ordinarily in the month of July to be called the ordinary General Body Meeting.

- 3. Any number of Extra-ordinary General Body meetings can be convened by the Executive Committee to transact business required or on requisition in writing addressed to the President made by not loss than 1/4th of the total strength of the General Body. It the requisition is not honoured by the Executive Committee within a month the requisitionists can convene such meeting by serving notice required on all the members provided that such no decision on any subject other than the one mentioned in the requisition can be taken in such a meeting convened by requisitionists
- 4. Business of the Ordinary General Body Meetings shall be
 - a) To receive and adopt the Annual Report of affairs of the Society and the working of the various institutions of the society.
 - b) To receive and adopt the audit report of the society.
 - c) To appoint auditors for the ensuing year.
- d) To elect Executive Committee once in every three years and

- b) The term of office of the Executive Committee shall ordinarily be for a period of Three Years from the date of election, provided that it shall continue till charge is taken over by the succeeding Executive Committee on election and provided further that the first Executive Committee shall continue for three years from the date of Registration of the Society.

POWERS OF THE STOCKER BY

12. OFFICE-BEARERS OF THE EXECUTIVE COMMITTEE

- i) The Executive Committee shall elect from amongst themselves, the President, the Vice President, the Secretary, the Joint-Secretary and the Treasurer for every term at its meeting to be hold entirely for the specific purpose of election at a meeting the agenda of which shall contain specific mention of the election.
 - ii) FILLING UP OF A VACANCY IN THE EXECUTIVE COMMITTEE
 - a) Any vacancy caused in the Executive by death, resignation or otherwhise of anybody, it shall be filled us by co-option of a member of the General Body for the rest of the term in its meeting by the Executive.
 - b) In the case of absence of the President or/and Secretary, the Vice President or/and Joint Secretary respectively shall discharge the respective functions of the President or/and Secretary.
 - c) In case of any vacancy of the office of the Treasurer, the President shall appoint a member to be the Treasurer, until Treasurer is co-opted.

13. POWERS AND FUNCTIONS OF THE EXECUTIVE MADE AND STREET OF THE EXECUTIVE

The Executive shall have the powers to do all acts, matters, things and deeds, which may be necessary or expedient in the furtherance of aims and objects of the Society and in particular the following.

- a) To manage and supervise the running of the Educational Institution.
- b) To look after and manage and supervise the properties or the Society.
- c) To employ and maintain employees of all categories.
- d) To fix curricula for the training of the employees.
- e) To appoint committees as and when necessary with such power as the Executive deems fit.
- f) To approve or reject applications for membership and accept resignation.
- g) To acquire in the name of the society by way of gift, purchase, exchange, lease or hire or otherwise any lands, buildings or any other type of property, documents, rights and privileges for the purpose of the Educational Institutions.
- h) To borrow or raise money which may be required upon bonds, debentures, promissory notes or other obligations by mortgage or exchange on property of the society subject to the prior sanction of the general body or subsequent ratification.
- i) To solicit, obtain or accept donations, grants, gifts, bequests and trusts from any person, firm, corporation or Institution.
 - j) To sell, manage, transfer, exchange, mortgage, dispose of or otherwise deal with any property whatever belonging to the society.
 - k) To amalgamate or affiliation, with or grant affiliations to any society having either partly or wholly - similarly objectives. I subject to the sanction of the General Body.

17. POWERS OF JOINT SECRETARY

He shall assist the Secretary in his functions and shall act as Secretary in the absence of Secretary.

18. POWER OF TREASURER

The Treasurer shall receive all moneys on behalf of the society and issue receipts there for.

FUNDS OF THE SOCIETY

- a) The funds the Society shall consist of all the monies collected in the shape of the different types of fees from the students, loans, gifts, donations or realisations or otherwise made by the society.
- b) The funds of the Society shall be deposited in any Scheduled Bank approved by a resolution of the Executive in the name of Jateeya Vidya Seva Samithi
- c) The account shall be operated by the Treasurer and the Secretary jointly.
- d) The funds of the Society shall be invested in accordance with the provisions of the section 13(1) (d) R.W.S. 11(5) of I.T. Act 1961.
- e) The Ir come and Fund of the society will be solely utilised towards the objects and no portion of it will be used for payments to the Trustee/Members by way of profit.
- f) The banefits of the Society are open to all, irrespective of caste, religion, sex etc., (c,d & f are additions made on 23-02-1996)
- 20. OFFICIALYEAR: The Official year of the society shall be from 1st April of a year to 31st March of the succeeding year.

21. AMENDMENTS TO THE COMMITTEE

The General Body specially convened for this purpose shall have the power to amend aims and objects, any existing rules and regulations of the Society, the proposal of which should have prior approval and consent of the executive and further any such amendment must be passed by 2/3rd majority of the members present and voting. Provided that no amendment shall be made without prior intimation to and permission of the Commissioner of Income Tax at the relevant time.

22. RIGHT OF MEMBERS TO THE PROPERTIES OF THE SOCIETY

No member shall have any right to the properties held by the society.

23. DISSOLUTION OR WINDING UP OF SOCIETY

- 1. A majority of members not less than 3/5th of the total members present at a meeting convened for the purpose may determine that JATEEYA VIDYA SEVA SAMITHI shall be dissolved or wound up whether forthwith or at any future date than agreed upon and on dissolution or winding up, the assets shall be transferred to a society having one or more identical or similar aims and objects as that of JATEEYA VIDYA SEVA SAMITHI as per section 13 of the societies registration Act XXI of 1860.
- 2. The society shall not transfer its funds and assets even after such resolution without intimating to and obtaining prior permission of Commissioner of Income Tax concerned at the relevant time.

24. GENERAL (additions made on 23-02-1996)

- a. The title of the Society shall be irrevocable.
- b. That no activities of the Society will be carried out anywhere outside India
- c. That the Society will not carry on any activity with the object of earning a profit.
